





STAR Metrics Project

- Project designed to measure the effect of federal investment in research
- Pulls data from various sources including institutional enterprise systems
- Hope to use as a model for gathering data such as what we are reporting for ARRA
- Currently in Phase II
- Around 100 institutions interested in participating

ARRA Burden Survey

- FDP is putting together a survey to try to determine the actual administrative burden that was added due to ARRA
- Data will be shared with OSTP and OMB
- In theory, ARRA reporting has a limited lifespan
- Rumors about extending ARRA reporting
- May ask AASCU members to participate
- Caveat: need to make sure it won't skew the data



Timeline for Survey

- August 30, 2010: FDP Meeting – ARRA session to discuss final draft of survey. Comments due by COB on September 8th.
- September 13: Distribute survey to all FDP member institutions
- October 11: ARRA Reporting due date
- October 29: Due date for all surveys to be complete
- November 1: Receive survey results
- November: Analyze survey results
- December: Begin to draft report and also follow up with any institutions for additional information or clarification as needed.
- December 15: Submit survey results & draft report to Exec. Committee
- Jan 9 – 11, 2011: FDP meeting. Present results of survey
