Whereas, The University of the District of Columbia's adherence to shared governance is tantamount to its continued success; and

Whereas, The University of the District of Columbia is about to embark on a self-study review; and

Whereas, the university administration has not responded to the faculty senate recommendations of 2/27/2012 with regard to the Department of Education; and

Whereas, the University administration has not responded to the faculty senate recommendations of 12/11/2012 with regard to NCUE; and

Whereas, the university administration has not responded to the faculty senate recommendations of 1/16/2013 with regard to University-wide requirements; and

Whereas, the university administration has not responded to the faculty senate recommendations of 2/12/2013 with regard to the Education Department and NCUE; and

Whereas, the university administration has not responded to the faculty senate recommendations of 10/08/2013 with regard to the Vision 2020 Plan; and

Whereas, the university administration has not responded to the faculty senate recommendations of 11/12/2013 with regard to the Vision 2020 Plan; and

WHEREAS, a new draft of the Vision 2020 has been written by the administration but not circulated for Faculty Senate input; and

WHEREAS, the university administration has not demonstrated a budget shortfall for the university; and

WHEREAS, the university administration has not provided a justifiable quantitative rationale for program eliminations; and

WHEREAS, a new draft of the Vision 2020 has been written by the administration but not circulated for Faculty Senate input;

THEREFORE BE IT RESOLVED that the University of the District of Columbia administration respond to Faculty Senate Recommendations to comply with the shared governance principles of the Middle States Accreditation as soon as possible, but no later than 1/31/2014.

THEREFORE BE IT RESOLVED that The University of the District Of Columbia administration give the Faculty Senate an opportunity to review the revised “Vision 2020 Plan” and future revisions to the “Vision 2020 Plan” and give the Senate adequate time to formulate its recommendations before submitting the Plan to the Board of trustees.
